- 1. Bob Feather called the meeting to order at 7:10 pm, and the Pledge of Allegiance to the Flag was conducted.
- 2. The yearly reorganization of the Paint Township Planning Commission was conducted:
 - a. Bob Feather made a motion to nominate himself to continue as Chairman, Patrick Greer seconded the motion.
 - b. Brian Ott made a motion to nominate Brian Weaver to continue as Vice-Chairman, Bob Feather seconded the motion.
 - c. Brian Weaver made a motion to nominate Brian Ott to continue as secretary, Bob Feather seconded the motion.
 - d. Voting for the slate of candidates was conducted as a block vote. The aforementioned three motions carried with unanimous approval.

- e. All three officers were then installed in their respective positions effective immediately.

- 3. The minutes from the November 25, 2009 meeting were reviewed. A motion to accept the minutes as read was made by Patrick Greer, and seconded by Brian Weaver. A vote was taken on the motion to accept the November 25, 2009 minutes and the motion was carried with unanimous approval. Note: The Paint Township Planning Commission does not hold a December meeting; therefore, no minutes for a December 2009 meeting were generated.

Old Business:

- 1. Joe Huff (TWP Supervisor) addressed the commission with an update on the Rambling Hills Development. Supervisor Andy Tvarzik is reviewing which roads still need to be repaired in Rambling Hills. Because more than 25% of the lots have now been sold in the development, construction in the development cannot be halted by the supervisors.
- 2. Patrick Greer completed and sent in the questionnaire that the Planning Commission received from Somerset County. The responses given on the questionnaire indicated that Paint Township is interested in receiving county assistance on the formulation of Long Range Comprehensive Planning, and on Planning for Parks and Recreation. To date the Planning Commission has not received any response from Somerset County.

New Business:

- 1. Joe Huff (TWP Supervisor) passed out an article entitled "No More Blight" from the Township Planner Magazine, and suggested that the planning commission members review the article, as the subject material may be relevant to future proceedings of the Planning Commission.

1. Bob Feather called the meeting to order at 7:06 pm, and the Pledge of Allegiance to the Flag was conducted.

2. The minutes from the January 13, 2010 meeting were reviewed. A motion to accept the minutes as read was made by Patrick Greer, and seconded by Brian Weaver. A vote was taken on the motion to accept the January 13, 2010 minutes and the motion was carried with unanimous approval. Note: The Paint Township Planning Commission's scheduled February 10, 2010 meeting was cancelled because of adverse weather. No minutes for a February 10, 2010 meeting were generated; however, a place-holder sheet was generated for the township's online planning commission files stating that the February 10, 2010 meeting was cancelled.

Old Business:

- 1. Somerset County Planning Questionnaire Patrick Greer completed and sent in the planning questionnaire that the Planning Commission received from Somerset County. The responses given on the questionnaire indicated that Paint Township is interested in receiving county assistance on the formulation of Long Range Comprehensive Planning, and on Planning for Parks and Recreation. Since the planning commission has heard nothing from Somerset County, Pat Greer called Brad Searfoss (Somerset Co. Planning Commission) on March 8, 2010 to ascertain status. Mr. Searfoss informed Mr. Greer that because of the adverse weather of the past month the county's resources, and the state's, resources have been directed toward snow removal. Mr. Searfoss advised he does not foresee any funding flowing down to the counties from the state for this initiative in the foreseeable future. Therefore, the activities of this initiative appear to be tabled for an indeterminate period of time.
- Rambling Hills Development Joe Huff (Paint TWP Supervisor) No drainage problems have been reported at the Rambling Hills Development during the recent melt-off of large amounts of snow.

New Business:

1. Paul Rummel – Attended the meeting seeking advice on sub-dividing the family farm between his father and his aunt. Questions centered on a business parcel that was taken off of the farm in the early 1990's. Specifically the questions related to how the business parcel would be counted in the current plans for subdivision. Chairman Bob Feather explained the rules governing previously separated parcels, and vice chairman Brian Weaver explained how right-of-ways need to be incorporated into a subdivision plan for landlocked parcels. Mr. Rummel will be hiring a surveyor to lay out the subdivision, and will return to the planning commission once the surveyor has completed his work, and drawing the appropriate maps. No voting action on this matter was required.

- 2. Pete Mishko Updated the Planning Commission on survey problems and undeeded property. Mr. Mishko enlisted the services of Musser Engineering, and surveyor Brian Kelly to correct a previous survey made by Jeff Ripple. Now that new maps of the Mishko property and adjacent parcels have been drawn the next step is for Mr. Mishko to hire an attorney for advice on how to lay claim to several small undeeded parcels that lie within the overall bounds of the subject Mishko property. The overall goal is to perform a land merger on the Mishko property and place all of the parcels on one deed. This merger; however, cannot take place because the undeeded parcels within the Mishko property separate the deeded parcels, and dis-contiguous mergers are not allowed. Mr. Mishko will keep the Planning Commission apprised of new developments. No voting action on this matter was required.
- 3. Doug Weaver Seeking advice on what is required for a major subdivision of his property along Spruce Run Road. The subject property was previously subdivided from the Robert McCreary farm. The commission advised Mr. Weaver that a PA DEP Storm Water Module must be completed for what he wants to do. Mr. Weaver will enlist the services of an engineer and a surveyor and return once the necessary storm water module has been completed. No voting action on this matter was required.
- **4.** Patrick Greer made a motion to set the next meeting for April 14, 2010. Thomas Pomroy seconded the motion, and all commission members in attendance unanimously approved the motion.
- **5.** A motion to adjourn was made by Brian Ott and seconded by Pat Greer. All commission members in attendance unanimously approved the motion.

- 2. The minutes from the March 10, 2010 meeting were reviewed. A motion to accept the minutes as read was made by Patrick Greer, and seconded by Brian Weaver. A vote was taken on the motion to accept the March 10, 2010 minutes and the motion was carried with unanimous approval.

- 1. The notes (1-a, 1-b) below concerning this matter are from the March 10, 2010 Planning Commission meeting minutes.
 - a. Somerset County Planning Questionnaire Patrick Greer completed and sent in the planning questionnaire that the Planning Commission received from Somerset County. The responses given on the questionnaire indicated that Paint Township is interested in receiving county assistance on the formulation of Long Range Comprehensive Planning, and on Planning for Parks and Recreation. Since the planning commission has heard nothing from Somerset County, Pat Greer called Brad Searfoss (Somerset Co. Planning Commission) on March 8, 2010 to ascertain status. Mr. Searfoss informed Mr. Greer that because of the adverse weather of the past month the county's resources, and the state's, resources have been directed toward snow removal.
 - **b.** Mr. Searfoss advised he does not foresee any funding flowing down to the counties from the state for this initiative in the foreseeable future. Therefore, the activities of this initiative appear to be tabled for an indeterminate period of time.
- 2. Rambling Hills Development Joe Huff (Paint TWP Supervisor) No drainage problems have been reported at the Rambling Hills Development to date this year. Rambling hills needs to complete Phase II of construction by September 30, 2010. A list of action items to be completed by said date is on file with the Paint TWP Supervisors. No building permits will be issued for Rambling Hills Phase II lots until the action item list is completed. The Planning Commission shall status this project each month until the completion of the action item list.
- 3. Winchester Estates Development Ed Rugg reported to the Paint TWP Supervisors that a top coat of roads within the development will be completed by November 2010. The Planning Commission shall status this project each month until the completion of the action item list.

New Business:

- 1. Ed Pitera Asked for status on the proposed Paint Township Sewer project along Route 160. Bob Feather suggested that Mr. Pitera would be able to get more information by attending the Paint Township Supervisors' Meeting at 3:30 pm on Tuesday April 20, 2010. No voting was required on this matter.
- 2. Charles Salsgiver Mr. Mark Walker (Paint TWP Inspector) received an inquiry via email from said party about land use covered under article 8 of the Paint TWP Land Use Regulations. Specifically the inquiry concerned Mr. Salsgiver's desire to open an auto salvage business, but it is unclear whether Mr. Salsgiver's targeted area is in Paint TWP or Windber Borough. In advance of the Planning Commission meeting, Mark Walker suggested that Mr. Salsgiver contact the Paint TWP Supervisors, and/or the Paint TWP Planning Commission. To date, no further inquiry has been received by either of the aforementioned bodies. No voting was required on this matter.
- **3.** Brian Weaver made a motion to set the next meeting for May 12, 2010. Bob Feather seconded the motion, and all commission members in attendance unanimously approved the motion.
- **4.** A motion to adjourn was made by Patrick Greer and seconded by Bob Feather. All commission members in attendance unanimously approved the motion. The meeting was adjourned at 8:00pm.
