Gentleman,

On February 21-2012, I attended the Paint Township Supervisors meeting, which was held at 3:30 PM at the Paint Township Municipal Building, 1741 Basin Drive.

As the meeting progressed a mister Jeffrey F. Silka of the Somerset County Industrial Development Authority was introduced to all present.

The purpose of Mr. Silka's attendance at the meeting was, to inform, explain, enlighten, and answer any and all questions that would arise pertaining to the proposed "zoning ordinance" being proposed for <u>all</u> of Paint Township.

Mr. Silka seemed very knowledgeable and forthright in answering questions that I and others had asked of him, in regards to zoning and existing land uses --- specifically --- existing <u>business land uses</u>.

Of the questions I asked Mr. Silka, two replies literally <u>astonished</u> me! I asked Mr. Silka, if zoning is implemented in Paint Township and an area is deemed residential – <u>with an existing business or landuse</u> "grand-fathered" in – how could that business or land –use <u>lose</u> its exemption and revert back <u>forever more</u> to be residential. I referred directly across the street – and even pointed to Blair Auto in particular.

Mr. Silka stated very clearly. If there was a fire and 51% of the building burned Blair Auto, under the zoning variance granted him would not be able to rebuild and the property would automatically revert forever to residential.

I said, "how can that be, in many instances a business can exist upon a property without the need of buildings to conduct business activities?

Mr. Silka's reply shocked and astonished me! Mr. Silka stated in <u>no uncertain terms</u>. "A business cannot exist without a building being present upon the business property." My reply was that is totally absurd! I than referenced my property directly behind Blair's Auto — which has had various business

activities conducted upon the land since 1974. I stated to Mr. Silka that there is <u>no building upon that property, because none is needed at present</u> and you are telling me I don't have a business property? His answer to me and the others present was an emphatic, <u>no you don't have a business property!</u>

It now seems very clear --- once again -- as with sewage in Paint Township individual property rights will be trampled, the taxpaying base will be ignored -- and a few will reap great benefits while the vast majority of Paint Township residents will have their "taste of a zoning type Obama Care," shoved down their throats!

At this point in time, I have no idea as to how the land upon which I reside and carry on business activities will be "zoned."

I am assuming that like the Paint Township Municipal Building and its supporting activities, which are many and varied, and is <u>very, very</u> much a "business activity" being carried out on a <u>daily basis, should</u> be classified "or zoned" as industrial.
